Background	<p>Building on strong local roots to address local challenges, social and solidarity economy (SSE) entities create quality jobs, contribute to inclusion of disadvantaged groups, driving inclusive and sustainable development across Asia and the Pacific. Social and solidarity economy entities address the multifaceted challenges and respond to transformations in the world of work, in and through their principle and values, such as pursuit of social mission and participatory governance. Attesting to its importance, the ILO, OECD, and UN have adopted Resolutions and Recommendation 2 acknowledging its role in the contributing to the attainment of the Sustainable Development Goals, encouraging Member States to implement enabling policies, programmes, and institutions for the social and solidarity economy.</p> <p>In Asia and the Pacific, understanding around the social and solidarity economy is still in its early stages, regarding its national definition, measurement, size, impact, potential and limitations. There are no framework laws or policies that encompass all elements of the social and solidarity economy, as defined by the ILC and UN resolutions. The ILO launched the project Strengthening Social and Solidarity Economy in Asia -Phase 2 to help policymakers, workers' and employers' organizations and practitioners better understand the social and solidarity economy's contribution to decent work and the Sustainable Development Goals (SDGs) and to inform and create policy dialogue in four countries – Cambodia, Mongolia, Thailand, and Vietnam.</p> <p>This regional workshop will feature the key findings from the four country case studies to shed light on the social and solidarity economy landscape, its contributions to decent work and sustainable development, challenges and opportunities and policy recommendations. The workshop will also feature case studies on the social and solidarity economy's role and contributions towards</p> <p>1) making supply chains more inclusive and sustainable, 2) facilitate the transition of informal workers and entities to the formal economy, 3) promoting a just transition towards environmentally sustainable economies and societies, and 4) promoting decent work in the platform economy.</p> <p>This workshop is organized by ILO and funded by the Government of the Republic of Korea.</p>
